TERMS & CONDITIONS

The Undersigned hereby makes Application for Electric Service at the above address and agrees to pay for said service, as measured by McMinnville Electric System's meter, in accordance with the applicable General Power Rate Schedule. The Customer agrees to permit authorized agents of MES free and safe ingress and egress to property of the Customer; and agrees that MES may utilize any and all necessary equipment which in the sole discretion of MES is necessary to serve Customer; including remote electric meter connection, disconnection, reading, inspection, and monitoring of any electric meter, or other such necessary equipment. Such access includes the right to remove or trim any tree that, in the sole discretion of MES, is deemed to inhibit MES's ability to safely provide electric service to the community or Customer. The customer hereby releases and agrees to hold harmless MES, the McMinnville Electric System Board of Public Utilities and its Directors and Officers, the employees of MES, and the City of McMinnville, from any and all claims for injuries to persons or property occurring beyond the Customer's weatherhead or Point-of-Delivery. MES assumes no duty or liability for injuries to persons, or property of the Customer, resulting from electrical voltage fluctuations or failure of MES to provide electricity to Customer. The customer agrees this application is subject to the MES Non-Residential Rules and Regulations, a copy of which is a part of this Agreement, and which is also available at the MES Administrative Office. I, the Undersigned, agree that in the event of default of the payment of any amount due, a monthly service charge will be added to the account until paid in full. If this account is placed with a collection agency or attorney for collection or legal action, the

Undersigned agrees to pay an additional charge equal to the cost of collection including collection agency, reasonable attorney fees, and court costs incurred, if any. The Undersigned further agrees to be bound by the Terms and Conditions of the Power Supply contract as may be modified, changed, amended, adjusted, or replaced from time to time by agreement between McMinnville Electric System and McMinnville Electric System's supplier of power. By signing below, and providing the cell phone number above, Customer agrees that MES may send text messages and / or alerts to Customer's cell phone number. Message and / or data rates may apply from Customer's mobile provider.

I, the undersigned, agree that in the event of default of payment of any amount due, a monthly service charge of 1% will be added to the account until paid in full, and if this account is placed with a collection agency or attorney for collection or legal action, to pay an additional charge equal to the cost of collection including collection agency fee (35% - subject to change), attorney fees, and court costs incurred, if any.
